30 **Sec. 2-264. – Subgroup established - Youth Advisory Board.**

- 31 (a) Pursuant to La. R.S. Section 46:1941.8(D), the New Orleans Children and Youth Planning
32 Board is authorized to establish committees or subgroups, but any such committee or
33 subgroup shall be subject to the provisions of R.S. 42:12 and 42:25, and all votes taken of
34 members shall be recorded and shall become matters of public record.
- 35 (b) To ensure the New Orleans Children and Youth Planning Board can fulfill its purpose and
36 functions, pursuant to Section 2-262, a subgroup of the board titled the Youth Advisory
37 Board is hereby established. The Youth Advisory Board shall consist of not less than 11

38 and not more than 25 individuals between the ages of 14 and 24 years, with all members
39 being residents of the City of New Orleans. Appointments shall be selected on an annual
40 basis by the New Orleans Children and Youth Planning Board or its Executive Director.”
